Notes

1. The excess for workers compensation means, subject to the agreed calculation method, the participant meets the weekly benefit payments (salaries) for the designated number of weeks. There is no excess on medical costs.
2. General Liability includes public and products, professional, directors and officers.
3. General Property includes property/business interruption, machinery breakdown and fraud. General property also includes electric scooters and wheelchairs but these have a **\$1 000** excess (in line with the excess for motor vehicle single-vehicle accident).
4. Travel is insured in the commercial insurance market. Different excesses apply to different policy benefits.
5. Marine Hull (including Protection & Indemnity cover) is insured in the commercial insurance market. Excesses vary for participants depending on the type and value of vessels.
6. Excess levels for light vehicles: **\$500** - multi-vehicle accidents, ambulances. **\$1 000** - single-vehicle accidents. **DPFEM - \$1 000** - all motor vehicle accidents.
7. The Fund provides stop loss cover for property damage to housing stock in excess of a stop loss level of \$15.75 million. Excesses that apply to individual claims are set by Housing Tasmania.
8. State Growth has a \$6.25 million excess on property damage to bridges, \$5 000 excess for the TMAG collection and a \$14 000 excess for general property.
